EAS PARTICIPANTS— The RMT must be rebroadcast within **60** minutes of reception. EAS Activations and the NPT, National EAS Test must be rebroadcast within **15** minutes of reception.

EAS Participants who receive a False EAS activation must report the activation to the FCC. Reports must be sent to the FCC Operations Center at FCCOPS@fcc.gov within 24 hours of determining that the activation was a False EAS activation. The report must include the date and time of the alert and any details noted by the Participant. For more information, see the 2026 Nevada EAS Plan.
